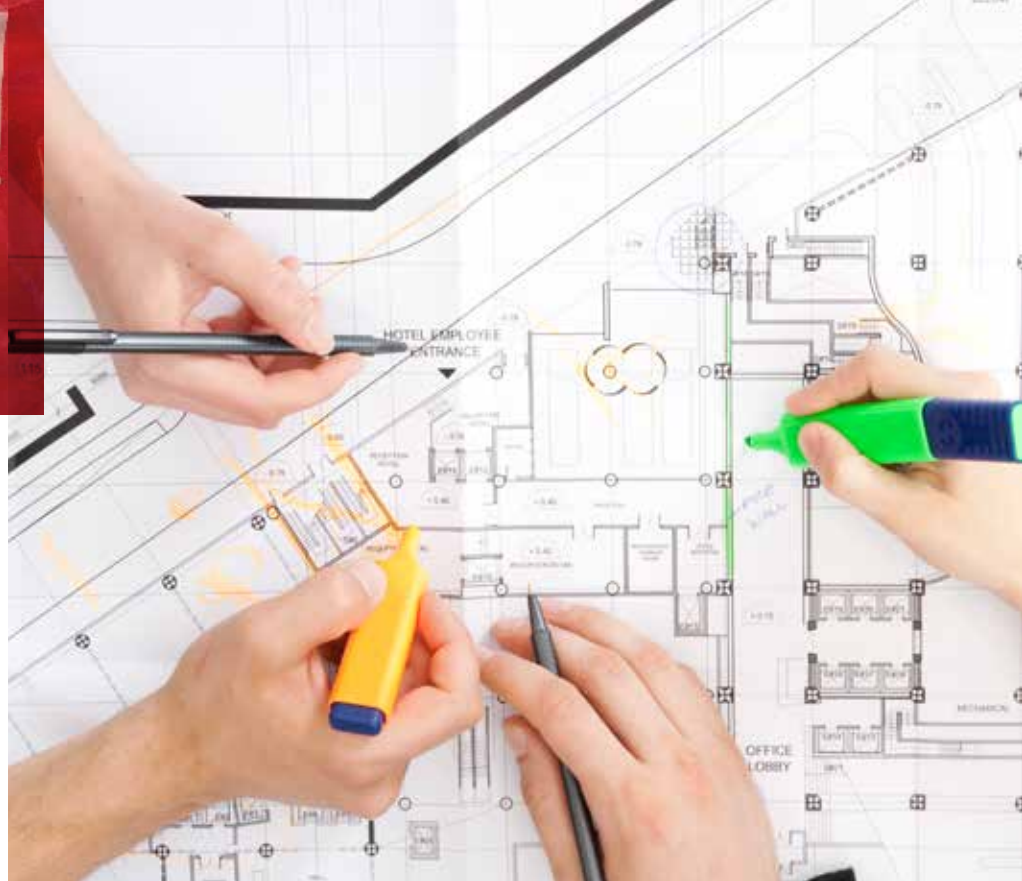

The release of AS 1851-2012 (Routine service of fire protection systems and equipment) introduces changes that affect many companies throughout the fire protection industry. This series of seminars, developed through feedback received at the December forums, will provide detailed insight into the technical content of the Standard and highlight how the new Standard will affect the day to day operations of many businesses and the industry as a whole.

This fourth series will address activities for first attack fire equipment included in AS1851-2012. The session will include technical content on delivery layflat fire hose, fire hose reels, portable & wheeled fire extinguishers and fire blankets.

In addition to the technical information, all seminars will provide valuable information on the administrative requirements detailed in Section 1 which covers important topics such as classification of defects, baseline data and systems interface testing. There will also be useful information provided on evidence of maintenance and responsibilities of technicians and service providers as well as avenues for training and accreditation.

Each of the speakers have been exposed to the development of the updated Standard and offer their expertise and experience through the presentation material. A panel session will provide the opportunity for direct engagement with the speakers about the subject material.

The material in this series is mostly technical in nature and targeted primarily at personnel and maintenance end users, however building owners and facilities managers would benefit greatly from understanding the changes to the Standard.
